- Local government officials in the municipalities traversed by the Project have been contacted personally by PSEG Long Island Staff. PSEG Long Island representatives met with officials from the Town of Huntington (March 19, 2025), the Town of Hempstead (March 20, 2025), and Nassau County (April 8, 2025) to notify them of the Project and planned filing. Additional meetings were offered to provide greater project specific information.
- PSEG Long Island Staff intends to meet with government officials from Suffolk County and the Village of Garden City to provide them with Project information.
- Government officials, identified in this Appendix as Attachment C-2 were sent, by first class mail on April 15, 2025, a letter with an included Project Fact Sheet notifying them of the Project. The Fact Sheet is included in this Appendix as Attachment C-3 and a form of the letter sent to government officials is included in this Appendix as Attachment C-4.

## **PUBLIC NOTICE APPLICATION OF PSEG LONG ISLAND ON BEHALF OF AND AS AGENT FOR THE LONG ISLAND LIGHTING COMPANY D/B/A/ LIPA FOR AN AMENDMENT TO A CERTIFICATE OF ENVIRONMENTAL COMPATIBILITY AND PUBLIC NEED PURSUANT TO ARTICLE VII OF THE PUBLIC SERVICE LAW**

### **TO WHOM IT MAY CONCERN**

PLEASE TAKE NOTICE that PSEG Long Island LLC on behalf of and as agent for the Long Island Lighting Company d/b/a LIPA (“LIPA” or the “Applicant”) intends to file an application (“Application”) with the New York State Public Service Commission (“Commission”) pursuant to Article VII of the Public Service Law (“PSL”) of the State of New York for an amendment (“Certificate Amendment” or “Amendment”) to a Certificate of Environmental Compatibility and Public Need (“Certificate”) for the construction, operation and maintenance of the Newbridge Bypass Project (“Project”). Before constructing the Project, the Applicant must receive a Certificate Amendment from the Commission.

### **DATE OF FILING**

The Applicant expects to file the Application with the Commission on or about April 15, 2025.

### **PROJECT DESCRIPTION**

The Project is the Applicant’s proposed work described below, which requires an Amendment to the Certificate issued for Lines 138-467 and 138-567 on November 23, 2005, in Commission Case 04-T-1687.

Line 138-467 runs underground from Stewart Avenue Substation to Newbridge Substation, both substations being in the Town of Hempstead, Nassau County. Line 138-567 runs underground from Newbridge Substation to Ruland Road Substation in the Town of Huntington, Suffolk County. Lines 138-467 and 138-567 were designed to operate at 345 kilovolts (“kV”) but have been operated at 138 kV since being placed in service in 2007.

As proposed, the Project would include: The extension of Line 138-467 to a new termination point west of Stewart Avenue Substation; the modification of that line and Line 138-567 to bypass Newbridge Substation; and the extension of Line 138-567 to a new termination point further east on the Ruland Road Substation property. With the modification of both lines to bypass Newbridge Substation, the result of the Project would be the combining of the two existing underground circuits into one, which the Applicant proposes to operate at 345 kV and designate as Line 345-567.

At Stewart Avenue Substation, Line 138-467 would be extended to the northwest by approximately 650 feet with open-cut trenching to a new termination point at a new substation proposed by a third-party developer. A new manhole would be installed just north of Newbridge Substation in a spare duct bank in the LIPA right-of-way to install new cable both east and west of the manhole; this would install approximately 1,500 feet of new cable through an existing duct

bank to the west and approximately 1,800 feet of new cable through an existing duct bank to the east. At Ruland Road Substation, Line 138-567 would be extended by approximately 1,400 feet to the northeast with open-cut trenching to a new termination point within LIPA property at a new substation proposed by a third-party developer.

### **LOCATION OF PROJECT**

The proposed route of the Project starts at Stewart Avenue Substation in the Village of Garden City, in the Town of Hempstead, Nassau County; traverses under the North Newbridge Road to the east of Newbridge Substation in the Town of Hempstead, Nassau County; and ends at the Ruland Road Substation in the Town of Huntington, Suffolk County. The locations of the Project's facilities will be depicted in the Application and associated figures.

### **AVAILABILITY OF APPLICATION**

A copy of the Newbridge Bypass Project Application will be served upon the chief executive officers of Nassau and Suffolk Counties and the Towns of Hempstead and Huntington and the Village of Garden City and a copy will be available for public inspection in each of the following locations: Uniondale Library, 400 Uniondale Avenue, Uniondale, NY 11553; Garden City Library, 60 7th Street, Garden City, NY 11530; Levittown Library, 1 Bluegrass Lane, Levittown, NY 11756; and Half Hollow Hills Community Library, 510 Sweet Hollow Road, Melville, NY 11747.

# Newbridge Bypass Project

*PSEG Long Island is committed to delivering best-in-class system reliability by expanding electrical capacity to meet the energy needs of the communities it serves, today and in the future.*

### Project Overview & Benefits

PSEG Long Island, as the agent of LIPA, is filing an application for an amendment to the Article VII certificate for Transmission Line 138-467 which connects the Stewart Avenue Substation in Uniondale to the Newbridge Substation in Levittown, as well as Transmission Line 138-567 which connects the Newbridge Substation to the Ruland Road Substation in Melville. The Newbridge Bypass Project would extend Transmission Line 138-467 to a new termination point, within LIPA-owned property, west of Stewart Avenue Substation, modify both lines to bypass the Newbridge Substation, and extend Transmission Line 138-567 east at the Ruland Road Substation within LIPA property.

The result would be the combining of the two existing lines into one, which will be operated at 345kV.

The line must be installed to meet current and future capacity needs and to continue the provision of safe, robust, and reliable service in the area.

#### Benefits Include:

- The modified 345kV electric transmission line will help ensure continued reliable service to the area and across Long Island.
- The modified line will be located entirely underground primarily under roads and rights-of-way except for certain above-ground electrical equipment within LIPA-owned property.
- Throughout construction, access to businesses and residences along the project route will be maintained.

# Newbridge Bypass Project

## Construction Process Overview

- **Splice Vaults Installation:**

One new underground vault will be installed within the LIPA right of way at the Newbridge substation to splice together the underground cable.

- **Existing Conduit:**

During construction existing conduit lines will be tied into the new splice vault and new conduit will be installed within LIPA property to new termination points.

- **Restoration:**

After completing the installation of the vaults, any excavated and disturbed areas will be seeded and restored.

- **Cable Installation:**

Underground cable arrives on trucks specifically designed for their installation. Crews will pull cable from the new vault to existing vaults along the project route.

- **Cable Splicing:**

Crews will set up a climate-controlled environment at the vault locations to splice the underground cables together. This activity is continuous for approximately one week for each vault.

## Substation Upgrades:

Equipment upgrades will be made within the LIPA-owned properties at the Stewart Avenue Substation and the Ruland Road Substation to create termination points for the connection of the 345 kV line.

**Re: Introduction to the Proposed Newbridge Bypass Project**

Dear Neighbor:

PSEG Long Island LLC (or PSEG Long Island), on behalf of and as agent for Long Island Power Authority d/b/a LIPA, has identified an important electrical need in your area, which will be addressed through the proposed Newbridge Bypass Project (the Project<sup>1</sup>). The Project is intended to increase the load capacity and reliability of the electric transmission system in the area and on Long Island.

Electric transmission lines play a crucial role in our power grid by carrying power from generation sources to the substations that serve residences and businesses in our communities with lower-voltage electricity. To reinforce LIPA's electric transmission system in your area, the Project would extend Transmission Line 138-467 to a new termination point on LIPA-owned property just west of Stewart Avenue Substation, modify both Transmission Lines 138-467 and 138-567 to bypass the Newbridge Substation, and extend Transmission Line 138-567 to a new termination point further east on the LIPA-owned Ruland Road Substation property. With the modification of both lines to bypass Newbridge Substation, the result of the Project would be the combining of the two existing underground circuits into one, which will be operated at 345kV.

The Newbridge Bypass Project is needed to meet current and future capacity needs and to continue the provision of safe, robust, and reliable service in the area. The Project is proposed to start construction in spring 2028 and be in service by spring 2030 for PSEG Long Island to meet the identified needs.

Construction will be performed with the intent of minimizing impact to residents and travelers in the area to the extent practicable. Throughout construction, access to businesses and residences along the Project route will be maintained. As part of the permitting process for the Newbridge Bypass Project, PSEG Long Island is consulting with Nassau County, Suffolk County, the Town of Hempstead, the Town of Huntington, the Village of Garden City, and pursuing State approval in the form of an amended "Certificate of Environmental Compatibility and Public Need" from the New York State Public Service Commission. PSEG Long Island is also consulting with the New York Department of Environmental Conservation, New York State Office of Parks, Recreation & Historic Preservation and the New York State Department of Transportation.

We want you to understand the nature of this project and its importance to your community. Along with this letter, we have included a fact sheet about the Newbridge Bypass Project which provides ways to communicate with us directly if you have further questions. PSEG Long Island LLC on behalf of and as agent for the Long Island Lighting Company d/b/a LIPA (“LIPA”), a wholly-owned subsidiary of the Long Island Power Authority (the “Applicant”), intends to file, on or about April 15, 2025, an application with the New York State Public Service Commission (“Commission” or “PSC”) for an amendment to a Certificate of Environmental Compatibility and Public Need under Public Service Law (“PSL”) Article VII for the construction, operation and maintenance of the Newbridge Bypass – Lines 138-467/567 project (the “Project”) in Nassau County and Suffolk County, New York.

The Project is the Applicant’s proposed work described below, which requires an Amendment to the Certificate issued for Lines 138-467 and 138-567 on November 23, 2005, in Commission Case 04-T-1687.

Line 138-467 runs underground from Stewart Avenue Substation to Newbridge Substation, both substations being in the Town of Hempstead, Nassau County. Line 138-567 runs underground from Newbridge Substation to Ruland Road Substation in the Town of Huntington, Suffolk County. Lines 138-467 and 138-567 were designed to operate at 345 kilovolts (“kV”) but have been operated at 138 kV since being placed in service in 2007.

As proposed, the Project would include: The extension of Line 138-467 to a new termination point west of Stewart Avenue Substation; the modification of that line and Line 138-567 to bypass Newbridge Substation; and the extension of Line 138-567 to a new termination point further east on the Ruland Road Substation property. With the modification of both lines to bypass Newbridge Substation, the result of the Project would be the combining of the two existing underground circuits into one, which the Applicant proposes to operate at 345 kV and designate as Line 345-567.

At Stewart Avenue Substation, Line 138-467 would be extended to the northwest by approximately 650 feet with open-cut trenching to a new termination point at a new substation proposed by a third-party developer. A new manhole would be installed just north of Newbridge Substation in a spare duct bank in the LIPA right-of-way to install new cable both east and west of the manhole; this would install approximately 1,500 feet of new cable through an existing duct bank to the west and approximately 1,800 feet of new cable through an existing duct bank to the east. At Ruland Road Substation, Line 138-567 would be extended by approximately 1,400 feet to the northeast with open-cut trenching to a new termination point within LIPA-owned property at a new substation proposed by a third-party developer.
